E - TERMS AND CONDITIONS OF CONTRACT

01. This agreement is for Disc Jockey services provided by POWERSTAR ENTERTAINMENT to the undersigned Client as listed in section A. This service is to be provided at the venue as listed in section B, on the date and times as listed in section C, and for the price as listed in section D.

02. POWERSTAR ENTERTAINMENT has agreed to perform the services of Disc Jockey for the price listed as total cost above in section D. The deposit is due at the time of contract signing. The remaining balance in full is due on the date of the event as listed in section C.

03. POWERSTAR ENTERTAINMENT accepts Cash and Personal Checks. All payments are to be made out to _____. Payments must be in United States Dollars (USD) and drawn from a bank operating within the United States of America.

04. In the event of non-payment, POWERSTAR ENTERTAINMENT retains the right to attempt collections through the Camden County courts. The Client, as listed in section A, will be held responsible for all court fees, legal fees, and collection costs incurred by POWERSTAR ENTERTAINMENT. The Client, as listed in section A, shall be charged \$25.00 USD for each check returned un-paid by the bank for any reason plus a \$50.00 USD late fee.

05. This agreement cannot be changed except by mutual written consent of both the Client and POWERSTAR ENTERTAINMENT. Deposits are non-refundable. In the event of a client/purchaser cancellation, balance owed is due within 30 days of date cancelled.

06. The Client shall at all times have complete control, direction, and supervision of the performance of services by POWERSTAR ENTERTAINMENT at this engagement and the Client expressly reserves the right to control the manner, means, and details of the performance of the services by POWERSTAR ENTERTAINMENT. A written event/music request list must be received by POWERSTAR ENTERTAINMENT at least one week prior to the date of the engagement for it to be included in POWERSTAR ENTERTAINMENT' programming guidelines. With or without the aid of a music request list, POWERSTAR ENTERTAINMENT shall attempt to play the Client's and the Client's guests music requests but shall not be held responsible if certain selections are unavailable. POWERSTAR ENTERTAINMENT will make an extra effort to have music requests available if they are received by POWERSTAR ENTERTAINMENT IN WRITING at least two weeks prior to the engagement.

07. The amount agreed upon and shown in section D above applies to the performance times set forth in section C of this agreement. This agreement guarantees that POWERSTAR ENTERTAINMENT will be ready to perform at the start time of the engagement. Additionally, POWERSTAR ENTERTAINMENT requests that they be permitted 60 minutes before the engagement and 60 minutes after the engagement for setup and takedown.

08. This agreement is not binding until received and signed by POWERSTAR ENTERTAINMENT. Any changes must be written and signed by both the Client and POWERSTAR ENTERTAINMENT. Oral agreements are non-binding. If any clause in this agreement is found to be illegal, the rest of the agreement shall remain in force.
